The following explanations of what not to do were written by Frank Warren, a very successful breeder and judge in the UK, and printed in the London and Southern Counties Journal.

What not to do

Don't Do It!

Don't take too seriously detailed instructions on how to train birds to keep them steady on the show bench. Some birds are natural showmen, others are, and always will be, fidgety. If spraying fairly frequently will not steady them, they are not likely to make good show birds no matter what trouble you take with them.

Don't send birds to a show which are obviously molting, or in poor condition, even though you have made the entries, it will be unfair to the birds, damage your exhibition record – worse still, you may lose a very valuable bird.

Don't blame a judge if he fails to notice in your birds good points which some other judge saw a week or so previously. The bird may be out of condition, the competition a lot stronger, or the first judge may have been wrong.

Don't attempt too many varieties if you have limited accommodation. It is far better to specialize in a few colours only to achieve success on the show bench.

Don't put too many hens together in a stock cage as they are bound to squabble – six to eight in a double stock cage should be the maximum.

Don't forget to put plenty of seed on the floor of the show cage.

Don't just moisten the feathers of the birds when spraying them. Wet them thoroughly. Always spray leaving plenty of time for the bird to dry before it rests for the night.

Don't fail to check over all cages before taking them to a show. Make sure doors are secure, correct class tickets are attached, and no bird is sent that has suddenly gone sick.

Don't, if you are an exhibitor, fail to give full support, active as well as financial, to your local and area Society.

Don't despair of the quality of a bird you think is good until you have shown it in good condition, under two or more of our best judges. I find that judges' opinions differ considerably, apart from which you do not know how your bird was behaving at the time it was judged, unless you are stewarding with him.

Don't criticise a judge until you are quite sure that you know what constitutes a first class exhibition budgerigar. All judges are not good ones, even though they are BS Judges. But we have to learn to live with it, if we are going to support our shows.





"FLECKING" as it is known has appeared on our exhibition birds since importation, and is a feature that has proved to be undesirable in any country world wide. In most overseas countries using the World Budgerigar Organisation Standard it is banned on the show bench now, after a period where it was tolerated, but birds with this feature were not allowed to be awarded any more than second place in their class.

Australia have accepted it in our exhibition and breeding birds for a long time but tried to discouraged it with penalties- "The heavier the flecking the heavier the penalty." This has not proved to be truly effective as we have seen birds with heavy markings on the head areas win their Variety at our National Show and Grand Champion Bird in their State Shows.

A decision has been made at the National Judges Meeting in May this year supported by the A.N.B.C. Delegates Meeting to ban heavily flecked birds from the show bench from January 2019. Prior to this the A.N.B.C. Judges Co-ordinator, James Bader sent out a survey to all A.N.B.C. Judges asking them to grade the pictures of the birds supplied into three areas, heavy, medium and light, which they did, and the results were collated with most judges agreeing on the decisions. From that survey came the decisions on the pictures of the birds, but it was decided to simplify it by making only Heavy and Light markings determinable at this time with the heavily flecked birds banned from the bench and the lightly marked birds receiving a penalty as before. Our Penalty and Disqualification clauses will include this, as well as the photographs to be used by Exhibitors and Judges to grade birds with flecking into one or the other- Disqualification or Penalty — see attached.


Some breeders feel that the decision to eliminate heavily flecked birds from the show bench in January 2019 is too soon. However it does not mean that you need to get rid of all your heavily flecked birds overnight because some of them may be the best budgerigars you own. What it does mean is that you will have to consider your pairings very carefully, with records to back your decisions, so that you will over time reduce the amount of head flecking in your stud and keep the quality features in your birds. At the 44th A.N.B.C. Championship Show in Penrith, Sydney this year heavy flecking was not an issue and that speaks for itself.









A.N.B.C. Secretaries Report 2018.

The year started off with the usual requirements of the running of the A.N.B.C. well under control. Everything, working smoothly.

Problems will always arise but not with the same degree of difficulty, hopefully. We embarked on the containerization of the essential items for the National Competition this year and ongoing. Purchasing of a shipping container, and all the necessary holding cages, show cages and staging / lighting etc. While only calling on all zones to contribute just \$700.00 per zone. The rest was able to be funded through the A.N.B.C.

The ring orders were back up to a very healthy 170,000 again. Even with the continuing no minimum, order requirement. There are some restrictions on quantities for coded. Example minimum 25 per code. Again quality was very good. Delivery efficient and on time as all zones Ring Registrars adapted to the format very well. Payment procedure direct at the bank worked again. But I have introduced an extra cost that if the supplementary order does not meet a respectable quantity I will be charging the bank fee onto the zone as well as the freight fee. Freight fee \$40.00. Bank transfer fee \$30.00.

It is a bit inconvenient and not profitable to the A.N.B.C. let alone consideration to me to be chasing and then paying multiple small amounts in international bank transfers. I do have other things to do in my life that are more exciting than running to the bank all the time to pay an account.

2019 Rings are black and the code which has been advised to all zones is ZWZA and they are one cent dearer than 2018 rings. That is \$0.49 each. Supplementary orders attract the freight cost as above per shipment. I have a percentage still incorporated into the cost, which we may have to address if certain regulations are brought in to being. Distribution is still the same pack and post on December 15th. of the year preceding the ring year.

Logies have been updated with the inclusion of the Dark Eyed Clears and distributed to four zones plus a spare to three if an exhibition class is introduced.

Budgerigar Society of N.S.W. Presented this weekend.

S.Q.B.B.A. 2019. B.C.V. 2020. S.A.B.S. 2021.

They have 28 each comprising of the current 27 standard classes and one etched with the A.N.B.C. standard only for an exhibition class variety which would be engraved on the name plate. 2 spare are held by me.

Golden Cob; valuable Sponsors great to deal with again. As the current sponsorship two year deal expired this year, a new two year agreement was agreed to earlier this year of which I thank their Sales and Marketing manager Simon Jenkins. He also distributed around 1,000 boxes of bird products divided into average quantities for all zones at no cost to the A.N.B.C. Of which I thought was very generous, and thanked him.

We managed one computer generated live meetings during the year and I believe while we have a way to go it looking positive. I hope they continue as we purchased the program to conduct these meetings. Thank you to James Smith for organising this and controlling the digital part necessary to have these meetings. There is still a bit of animosity towards meetings of this type.

While on the computerization subject there was a problem created for B.S.N.S.W. for the scoring of the National Competition. A new program had to be devised and purchased. I have asked two others for their program and interpretation of them. This will give me hopefully three programs that we can make available to every zone in Australia and they can then pick the one they deem easiest for them to implement when it is their turn to host the Competition. I was very disappointed at the very least and I will not have my / our hobby held to ransom or at risk of upsetting the weekend for any zone or my enjoyment in birds. As the last 28 to 30 years, attending and being involved in every one attests to.

The web site while a work in progress and moving forward of which my thanks go to Karlene McLoughlin from Nth. Qld. But she has intimated to me because of family commitments will not be continuing, after this weekend so more searching will have to be done. I have made advances I hope in the right arena.

I hope the bird transport to and the venue this year was efficient. Please keep this essential priority at the for front to all zones future planning.

There is also livestock government legislation in Victoria and N.S.W. that the B.C.V. and the B.S.N.S.W. is actively involved in that will require positive directives being implemented by societies to adhere to, to satisfy everyone. The Containerization of essential items for the running of the National competition this year seemed to work extremely well. Our thanks must go to Dave Ganzer for his enormous amount of time effort and donation input to this project.

I again would like to thank the following for their ongoing support of me in this position. Being the committee members; President Steve Cummins. Past President Russell Ogden. Colour & Standards & financial adviser Peter Glassenbury, Judges Co-ordinator James Bader, Public Officer Dave Butters, A.B.A. Representative Bruce Bradford, Auditor Bruce Sheppard, Karlene McLoughlin for the Web site and all the Zone Secretaries and Ring registrars.
